# **Modern Slavery Statement**

#### Introduction

All our suppliers and subcontractors have been risk assessed against our Environmental and Sustainability Policy and Behaviour and Culture Policy as modern slavery is a key element of that.

Staff receive modern slavery training to educate and help enable identification of concerns within our supply base.

Our approach to Sustainability is continually assessed and reviewed. We work to ensure our goals are communicated to our wider business and work to meet and exceed these in the coming years.

We will regularly assess the effectiveness of all actions, to ensure that they meet our objectives, and to determine whether further steps are required.
